Dear Friend of Saint Martin,

As a teacher of theology for many years, I am sure I had read the line before but, that particular morning it hit me with a whole new meaning. 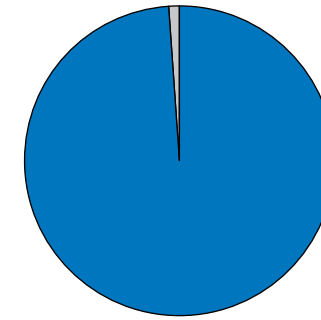

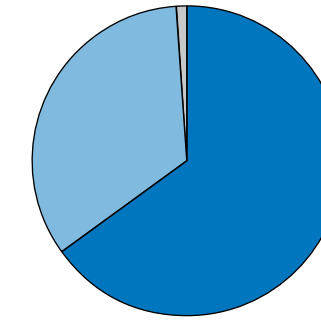

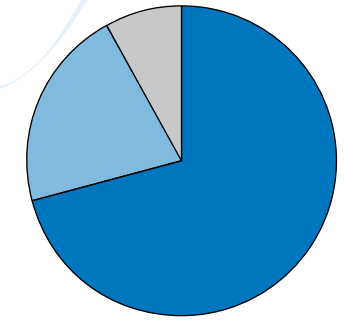
